# March 2nd, 10 am, "What is Weighty, Wise and Whimsical" led by Jeff Lockwood

This Sunday, Jeff Lockwood will lead an exploration of the enchantment of aphorisms—those pithy statements offering instruction, truth, or opinion on abiding matters of the human condition. We'll make use of a provocative sampling from *What Remains to be Said*, a recently published collection by Yahia Lababidi, who is an Arab-American of Palestinian background and the author of 13 acclaimed books of essays, poems—and aphorisms (and Jeff's newfound pal). With these to prime our contemplative, spiritual pumps, we'll craft our own bits of succinct wisdom to distill thoughts and feelings into adages such as, "If you judge a fish by its ability to climb trees, it will spend its whole life thinking it's stupid," "We become what we repeatedly do," or "Hurt people hurt people."

**Treasurer's Report**: Our Pledge income jumped last month to 74% of anticipated primarily due to major contributions coming from Qualified Charitable Contributions. In addition, we received a \$1000 donation from Patagonia via its charitable foundation. Expenses, on the other hand, are running well within our budget for the year.

**Chocolate Fiesta**: We cleared \$1683 from the Chocolate Fiesta and have sent a contribution in that amount to the League of Women Voters of Laramie.

**Building**: The Board approved an estimate of \$3500 from Capitol Roofing for another attempt to repair the leak over the entryway.

**Memorial Plaque**: The Board suggested that the Caring Committee create a simple form for members to nominate deceased members for inclusion on the Memorial Plaque. Robin volunteered to help with this task.

Nominating Committee: Linda Meeker agreed to head up the Nominating Committee in preparation for our annual meeting in May.

**Canvass Committee**: Jeff Lockwood and Sara Saulcy agreed to head up the Canvass Committee for this Spring's Pledge campaign. The COM should have finished its recommendation for how best to fulfill our ministry goals before the Pledge Campaign, so any anticipated additional expenses can be included in the proposed budget for 2025-2026.
